BUYER'S RIGHT TO CANCEL

The Member has the right to cancel this contract within three (3) business days after the date of the signing of the contract by notifying Canine Funtime, LLC at the above address or hand delivering the notice to Canine Funtime, LLC with receipt before twelve midnight (12:00 A.M.) on the third business day after the date of the contract. Such notice must say that the Member does not wish to be bound by this contract and be accompanied by the contract forms, membership cards, and any and all other documents as evidence of indebtedness signed by the Member will be cancelled by Canine Funtime. Member may also cancel this contract if Canine Funtime moves or goes out of business and fails to provide alternative facilities within five (5) miles of the location designed in this contract. If Member so cancels, Canine Funtime may retain or collect a portion of the contract price equal to the proportionate value of the services or use of facilities Member has already received. Member may also cancel if they become disabled, and their estate may cancel in the event of members death. Member must prove such disability by a doctor's certificate and Canine Funtime, LLC may also require that Member submit to a physical examination by a doctor agreeable to Member and Canine Funtime. If this contract is cancelled, Canine Funtime, LLC shall refund the Member or his estate funds paid or accepted in payment of the contract in an amount computed by dividing the contract price by the number of days in the contract term, and multiplying the result by the number of days remaining in the contract term.
