**MEMBERSHIP RULES AND REGULATIONS**

**CHECK IN**

Members must check in each time that they use the dog park. To check in, please present current membership card at the front desk upon arrival. Dog park usage may be denied if member does not present card.

The facility may either close or operate at reduced hours on holidays. Business hours, policies, and regulations are subject to change without notice.

**MEMBERSHIP FEES**

Membership use and services must be paid in advance. All fees and schedules are subject to change without notice. Prepaid memberships are non-refundable and non-transferable.

The obligation to pay dues is not dependent on the availability of all the amenities and services the facility offers. Special engagements, repairs and maintenance may make it necessary to restrict use of, or close, one or more of the amenities and or services within the facility. Dues will not be reduced or suspended during the time when one or more of the amenities and or services are not available.

**THREE-DAY RIGHT OF RESCISSION**

New members have three days after signing the membership agreement to cancel their membership without penalty. If the new membership agreement is cancelled within three days, Canine Funtime will return to the member within thirty days all amounts paid. To cancel, new members must come into Canine Funtime and inform the management personnel of their wish to cancel.

**ATTIRE**

Proper attire is required for participants using the club and subject to the approval of Canine Funtime.

**EQUIPMENT**

All equipment must be used as designed. If you are not familiar with use of equipment and facilities, please arrange instruction with a staff member. Instruction is available to members as part of your membership. Members must be familiar with and observe club rules and regulations posted in the club area. Members who do not observe club rules and regulations or who abuse equipment and facilities in any fashion will be asked to leave. The management reserves the right to terminate membership to anyone who refuses to observe any of the club's rules or regulations.

**CONDUCT**

Canine Funtime is committed to the health, safety, and welfare of each of its members, member's canines and staff. Canine Funtime does not tolerate unreasonable, threatening, obscene, harassing, indecent or illegal behavior. Canine Funtime has the right to judge behavior and respond accordingly. This right includes, but is not limited to, termination of membership of any member engaging in unacceptable behavior.

**LOCKER ROOMS**

Lockers are available for member while attending the facility. A locker key is available at the check in desk.

**CHILDREN**

Children must be supervised at all times.

**DAMAGES**

Any member, member's guest, or dependent children willfully or neglectfully causing damage to the club's property shall pay for damages.

**LOST ARTICLES**

The club assumes no responsibility for lost or stolen articles. Lost and found articles not claimed will be donated to charity.

**SMOKING**

No smoking is allowed in any part of the facility.
